At our September, 2017 meeting, Ill. Hoyt O. Samples, 33° SGIG Emeritus, presented a program regarding the Feast of Tishri and why it is significant to Scottish Rite Masons.



THE FEAST OF TISHRI

In Scripture, the Feast of Tishri was instituted to be observed on the 15th day of the Hebrew month Tishri which is the 7th month of the Jewish religious calendar.

Tishri was the most joyful and festive of all the seven major feasts in Israel and was to serve as an annual reminder of God's provision during the forty-year wilderness sojourn of the Israelites.

THE FEAST OF TISHRI (CONT'D)

The feast celebrated God's past goodness and provision during the time of wilderness wandering and God's present goodness for completion of the harvest and for the hope of rain which provided sustenance for Israel.

The two major symbols of the Feast of Tishri are water and light. Each morning the high priest would pass through the Watergate to the pool of Siloam where he would gather about a quart of water in a golden pitcher and return, flanked by people waving palm fronds, whereupon he would ascend a structure in the courtyard of the temple and pour the water down a trough symbolizing the rainy season and the blessings of God coming from Heaven.

In the evening, there were four towering menorahs each with seven candlesticks. The wicks of the candlesticks were made from the old linens derived from the clothing of the Levites.

The Feast of Tishri is referred to in the gospel of John, chapter 7, versus 37-38, wherein it said, "In the last day, that great day of feast, Jesus stood and cried, saying, 'If any man thirsts, let him come unto me and drink.'"

The gospel of John also records these words from John 8:12 and John 9:5: "Then spoke Jesus again saying, 'I am the light of the world: he that follows me shall not walk in darkness, but shall have the light of the world.'"

Thus, the Feast of Tishri to the Scottish Rite Mason represents the commemoration of God's past blessings and the promise of future blessings to all of those who seek the true light.


